Gyrostat Risk Managed Equity Fund – Address uncertainty through portfolio construction - Lower beta with alpha for diversification benefits with a 14 year track record of returns increasing with market volatility (including large market falls).

5 classes: - Regular equity income (absolute return benchmarks) and Australian and international equities (index return benchmarks) with protection always in place against major market falls (sequencing).

Headquartered in Melbourne, Australia, Gyrostat are specialists in delivering diversification benefits through low and non correlated investment solutions which address sequencing and portfolio drawdown risk while delivering equity income (derived from dividend pass through and risk management overlay profits).

The flagship Gyrostat Absolute Return Income Equity Class A has a track record exceeding fourteen years with no quarterly drawdown greater than a pre-defined 3% limit.

Class B has a greater focus on returns and may not necessarily gain from major market falls. Low correlation to the Australian market.

MONTHLY UPDATE	CLASS OVERVIEW
<p>Cum NAV per unit was \$0.6205 and cash distribution per unit was \$0.0155. Total NAV of the Fund was \$16.4m.</p> <p>The Australian market traded lower in March but still remains near 52W and all-time highs. The price of risk, as measured by the VIX, has fallen significantly since October 2022 level of 32.02, reducing the cost of protection. During March, the price of risk increased and then fell significantly, ending the month modestly higher.</p> <p>Our portfolio provides the diversification benefits of lower risk, higher risk-adjusted returns, and reduced exposure to market shocks which are more apparent in volatile markets (wider trading range, increasing cost of protection).</p> <p>With our approach we do not need to engage in debates about market direction, it is the differing market predictions and general uncertainty that generate our returns, as these cause changes in stock prices and the price of risk.</p> <p>Gains from RIO, FMG, BHP and WDS offset modest losses in XJO with a significant NAV increase for the month and quarter.</p> <p>We anticipate strong investment performance with volatility favourable to our 'dynamic hedging' risk management approach. A more active asset allocation approach, particularly into higher yielding stocks, in the upcoming dividend cycle has been adopted. The next dividend cycle is in banking stocks in May.</p>	<p>Strategy: Designed to produce higher income (compared to an investment in the Class A Units) through the complete investment cycle (downside protection always in place). In contrast to the Class A Units, Class B Units has a greater focus on returns and may not necessarily gain from major market falls. Low correlation to the Australian market.</p> <p>Purpose: These returns are non correlated with the market providing portfolio diversification benefits such as lower risk, higher risk-adjusted returns, and reduced exposure to market shocks</p> <p>Investment Objectives:</p> <p>Return: To exceed income distributions over rolling 12 months.</p> <p>Income: > BBSW3M + 6% p.a. from dividends and risk management profits paid quarterly.</p> <p>Protection: 6% quarterly downside risk tolerance.</p> <p>Distributions may be higher dependent on the Class performance.</p> <p>Class B buys and holds ASX-20 and International listed equities and options with the relevant exchange as the derivative counterparty. The Class may borrow up to 100% of the Class assets.</p> <p>Class B is a levered version of Class A to deliver higher income and higher risk tolerance than Class A. Our expectation is that <u>over the cycle</u> we will achieve our income and return objectives while operating with our pre-defined risk parameters.</p>
