This Information Memorandum (**IM**) has been prepared by Gyrostat Capital Management Pty Ltd ACN 138 219 002 AFSL 452917 (**Gyrostat Capital, we or us**) as Trustee for the Gyrostat Risk Managed Equity Fund (**Fund**). This IM sets out general information about the Fund for the recipient of this IM (**Recipient**) to consider in making a decision as to whether the Recipient should investigate a possible investment in the Fund.

This IM is supplied personally to the Recipient on the conditions set out below, which are expressly accepted and agreed to by the Recipient, in part consideration of the supply of the IM, as evidenced by the retention by the Recipient of this IM. If these conditions are not acceptable the IM must be returned to us immediately.

### Fund Reorganisation

Prior to 1 March 2021, the Fund was called the Gyrostat Absolute Return Income Equity Fund and had issued one class of Units. The Fund is now called the Gyrostat Risk Managed Equity Fund and has (or will) issue five Classes of Units.

### Classes of Units

The Fund has (or will have on issue) Units in different unit classes, which differ in their investment opportunities, targeted return, risk profiles and fees. The assets and liabilities of each relevant Class will be contractually segregated from the assets and liabilities of each other Class This IM relates to the offer of:

- Gyrostat Absolute Return Income Equity Class or Class A Units.
- Gyrostat Leveraged Absolute Return Income Equity Class or Class B Units.
- Gyrostat Risk Managed Australian Equity Class or Class C Units.
- Gyrostat Risk Managed Hong Kong Equity Class or Class D Units.
- Gyrostat Risk Managed Global Equity Class or Class E Units:

Additional Classes of Units may be issued from time to time.

## Investment Strategy

The Investment Strategy for each Class is set out below:

### **Gyrostat Absolute Return Income Equity Class or Class A Units:**

For this Class Gyrostat Capital predominantly holds assets in high yielding blue chip stocks listed on the Australian Securities Exchange (**ASX**), and cash, while investing in the ASX options market or international options market to mitigate risk. No more than 15% of the Class assets may be invested in international assets including the international options market. The Trustee may borrow up to 30% of the value of the Class assets (measured at the time of debt incurrence) on a secured or unsecured basis.

This Class is designed to increase in value on major market falls (downside tail always in place) with regular income through the complete investment cycle. Low correlation to the market.

### **Gyrostat Leveraged Absolute Return Income Equity Class or Class B Units:**

For this Class Gyrostat Capital predominantly holds assets in high yielding blue chip stocks listed on the Australian Securities Exchange (**ASX**), and cash, while investing in the ASX options market or international options market to mitigate risk. No more than 15% of the Class assets may be invested in international assets including the international options market. The Trustee may borrow up to 100% of the value of the Class assets (measured at the time of debt incurrence) on a secured or unsecured basis.

This Class is designed to produce higher income through the complete investment cycle.

### **Gyrostat Risk Managed Australian Equity Class or Class C Units:**

For this Class Gyrostat Capital predominantly holds the ASX200 ETF and cash, while investing in the ASX options market to mitigate risk. Holdings may also include individual stocks and options. The Trustee may borrow up to 100% of the value of Class assets (measured at the time of debt incurrence) on a secured or unsecured basis,

This Class is designed to outperform the ASX200 over rolling 12 months whilst mitigating the investor against large losses with protection always in place (ie: to address sequencing risk).

### **Gyrostat Risk Managed Hong Kong Equity Class or Class D Units:**

For this Class, Gyrostat predominantly holds the HSI Net Total Return Index, Hong Kong dollar denominated cash and cash-equivalent investments and exchange-traded derivatives on the Hong Kong Stock Exchange to mitigate risk. Holdings may also include individual international listed equities and exchange-traded derivatives listed on the Hong Kong Stock Exchange. This Class will not invest in assets located in Australia. This Class may borrow up to 100% of Class assets (measured at the time of debt incurrence) on a secured or unsecured basis.

This Class is designed to mitigate major losses on large market falls (downside protection always in place).

### **Gyrostat Risk Managed Global Equity Class or Class E Units**

For this Class, Gyrostat predominantly holds the MSCI All Country World Index, US dollar denominated cash and cash-equivalent investments and exchange-traded derivatives on the Chicago Board of Exchange or Intercontinental Exchange to mitigate risk. Holdings may also include individual international listed equities and exchange-traded derivatives listed on the Chicago Board of Exchange or Intercontinental Exchange. This Class will not invest in assets located in Australia. This Class may borrow up to 100% of Class assets (measured at the time of debt incurrence) on a secured or unsecured basis.

Designed to mitigate major losses on large market falls (downside protection always in place).

**The Fund**

Gyrostat Capital's investment philosophy is founded on the belief that conventional portfolio design that seeks to generate income and/or capital growth is prone to undesirable volatility and large negative shocks. Gyrostat Capital aims to mitigate and control this volatility, while achieving stable returns with regular income streams over the medium-to-long term. In designing the Fund, Gyrostat Capital seeks to provide solutions for a low interest rate environment and major market corrections. Gyrostat Capital's objective is to deliver a regular and stable income stream with capital security.

The Fund offers five classes of units; Gyrostat Absolute Return Income Equity Class, Gyrostat Leveraged Absolute Return Income Equity Class, Gyrostat Risk Managed Australian Equity Class, Gyrostat Risk Managed Hong Kong Equity Class and the Gyrostat Risk Managed Global Equity Class. Each Class has differing risk-return characteristics, but all Classes are based on the risk managed approach developed by Gyrostat Capital. Gyrostat Leveraged Absolute Return Income Equity Class Units are levered Gyrostat Absolute Return Income Equity Class Units. Gyrostat Risk Managed Australian Equity Class Units are a risk managed Australian index asset. Gyrostat Risk Managed Hong Kong Equity Class and the Gyrostat Risk Managed Global Equity Class are international index assets. Each Class is backed by a Class specific pool of assets and liabilities held on a segregated basis.

### **Gyrostat Absolute Return Income Equity Class or Class A Units investment objectives:**

Designed to reliably increase in value on major market falls (downside tail always in place) with regular income through the complete investment cycle. Low correlation to the market.

Asset classification: “*alternative – defensive*”

**Target Total Return\*:** 6% - 8% p.a. in trending markets, greater than 8% p.a. in changing markets, BBSW 90 + 3% p.a. in stable markets

**Target Income Return:** Minimum cash rate BBSW 90 + 3% from dividends, franking credits and risk management profits paid quarterly

**Protection:** No quarterly Net Asset Value draw-downs exceeding 3%

**Benchmark:** BBSW90 days + 3% pa

This Class is an absolute return Class with a benchmark for performance measured against the bank bill swap rate 90 day plus 300 basis points (3.0%). Returns are designed to increase with market volatility. The returns guidance is based upon 3 broad market groupings (stable, trending, and changing). The key factors we use are the market range from low to high, and the number of ‘reset’ opportunities (i.e.: price movements + - 3%) within this range.

The Manager seeks to achieve this in the medium term irrespective of movements in the stock market. The Manager predominantly buys and holds blue chip stocks listed on the ASX. We simultaneously enter the ASX options market or international options market to hedge risk. Designed to mitigate major losses on large market falls (downside protection always in place).

Asset classification: “*Australian equities*”

**Target Total Return\*:** To exceed ASX200 accumulation index over rolling 12 months

**Target Income Return:** To match the ASX200 accumulation index

**Target Protection:** Always in place to mitigate losses against large market falls to address sequencing risk

**Benchmark:** ASX200 accumulation index

This Class is benchmarked against the ASX200 Accumulation Index. Gyrostat Capital predominantly holds the ASX200 ETF, and cash, while investing in the ASX options market to mitigate risk. Holdings may also include individual stocks and options.

The Manager may borrow up to 100% of the value of Class assets (measured at the time of debt incurrence) on a secured or unsecured basis.

**Gyrostat Risk Managed Hong Kong Equity Class or Class D Units investment objectives:**

Designed to mitigate major losses on large market falls (downside protection always in place).

Asset classification: *"Hong Kong equities"*

**Target Total Return\*:** Outperform HSI Net Total Return Index over rolling 12 months

**Target Income Return:** Match the HSI Net Total Return Index

**Target Protection:** Always in place to mitigate losses against large market falls to address sequencing risk

**Benchmark:** HSI Net Total Return Index

This Class is benchmarked against the HSI Net Total Return Index and the Class currency is Hong Kong dollars. For this Class, Gyrostat predominantly holds the HSI ETF, Hong Kong dollar denominated cash and cash-equivalent investments and exchange-traded derivatives on the Hong Kong Stock Exchange to mitigate risk. Holdings may also include individual international listed equities and exchange-traded derivatives listed on the Hong Kong Stock Exchange. This Class will not invest in assets located in Australia. This Class may borrow up to 100% of Class assets (measured at the time of debt incurrence) on a secured or unsecured basis.

**Gyrostat Risk Managed Global Equity Class or Class E Units investment objectives:**

Designed to mitigate major losses on large market falls (downside protection always in place).

Asset classification: *"Global equities"*

**Target Total Return\*:** Outperform MSCI All Country World Index over rolling 12 months

**Target Income Return:** Match the MSCI All Country World Index.

**Target Protection:** Always in place to mitigate losses against large market falls to address sequencing risk

**Benchmark:** MSCI All Country World Index

This Class is benchmarked against the MSCI All Country World Index and the Class currency is US dollars. For this Class, Gyrostat predominantly holds the MSCI All Country World ETF or equivalent components, US dollar denominated cash and cash-equivalent investments and exchange-traded derivatives on the Chicago Board of Exchange or Intercontinental Exchange to mitigate risk. Holdings may also include individual international listed equities and exchange-traded derivatives listed on the Chicago Board of Exchange or Intercontinental Exchange. This Class will not invest in assets located in Australia. This Class may borrow up to 100% of Class assets (measured at the time of debt incurrence) on a secured or unsecured basis.

\* Target Total Return are inclusive of income, franking credits where relevant and capital growth.

The above objectives represent the target returns and parameters of the Fund. The Trustee and the Investment Manager do not guarantee that the above target returns and investment objectives or parameters will be achieved.

## RISKS OF INVESTING

**Investors should note that all investments carry risk. Different investment strategies may carry different levels of risk, depending on the assets that make up the strategy. Assets with the highest long-term returns may also carry the highest level of short-term risk.**

**Investors should also be aware that the value of the underlying investments of the Class may vary. Further, the level of returns for a Class may vary and future returns may differ from past returns. Returns for a Class are not guaranteed and investors may lose some or all of their money. The level of risk acceptable to a particular investor will differ depending on various factors including their age, investment time frame, where other parts of their wealth are invested and their risk tolerance.**

The following is a summary of what Gyrostat Capital considers to be the significant risks of investing in the Fund and its underlying investments. Recipients and potential investors should carefully consider the following significant risk factors that may affect the performance of the Fund before making an investment in the Fund.

### ***General***

The investment activities of certain investors are subject to legal investment laws and regulations, or review or regulation by certain authorities. Each prospective investor should consult its legal advisers to determine whether and to what extent (i) Units are legal investments for it, (ii) Units can be used as collateral for various types of borrowing and (iii) other restrictions apply to its purchase or pledge of any Units. Financial institutions should consult their legal advisers or the appropriate regulators to determine the appropriate treatment of Units under any applicable risk-based capital or similar rules.

Before making an investment decision prospective purchasers of, or investors in, Units should conduct such independent investigation and analysis (together with taking such professional advice as they deem appropriate under the circumstances) regarding Gyrostat Capital, the Fund and the portfolios, the Investment Manager and the Custodian and all other relevant persons and such market, economic and other factors as they deem appropriate to determine whether such investment is fully consistent with their financial needs, objectives and condition, complies with and is consistent with all investment policies, guidelines and restrictions applicable to them and whether it is a fit, proper and suitable investment for them, notwithstanding the clear and substantial risks inherent in investing in or holding the Units.

As part of such independent investigation and analysis, prospective purchasers of, or investors in, the Classes of Units should consider carefully all the information set forth in this Information Memorandum relating to the Fund and the considerations set out below.

Prospective purchasers of, or investors in, the Classes of Units may not rely on Gyrostat Capital or any of its respective affiliates in connection with its determination as to the legality of its acquisition of the Units or as to the other matters referred to above.

### ***Assessment of investment suitability***

Each prospective investor in a Class must determine the suitability of that investment in light of its own financial circumstances and investment objectives, and only after careful consideration with its financial, legal, tax and other advisers. In particular, each prospective investor should:

- have sufficient knowledge and experience to make a meaningful evaluation of the Class, the merits and risks of investing in the Class and the information contained in or incorporated by reference in this Information Memorandum or any applicable supplement;
- have access to, and knowledge of, appropriate analytical tools to evaluate, in the context of its particular financial situation, an investment in a Class and the impact the Class will have on its overall investment portfolio;
- have sufficient financial resources and liquidity to bear all of the risks of an investment in a Class;
- understand thoroughly the terms of a Class and be familiar with the behaviour of any relevant indices and financial markets; and
- be able to evaluate (either alone or with the help of a financial adviser) possible scenarios for economic, interest rate and other factors that may affect its investment and its ability to bear the applicable risks.



The Units are complex financial instruments. Sophisticated investors generally do not purchase complex financial instruments as stand-alone investments. They purchase complex financial instruments as a way to reduce risk or enhance yield with an understood, measured and appropriate addition of risk to their overall portfolios. A prospective investor should not invest in Units which are complex financial instruments unless it has the expertise (either alone or with a financial adviser) to evaluate how the Units will perform under changing conditions, the resulting effects on the value of the Units and the impact this investment will have on the prospective investor's overall investment portfolio. Units may be redeemable at an amount below their issue price in which case investors may lose the value of part or their entire investment.

Prospective investors intending to purchase Units to hedge against the market risk associated with investing in a reference share (or basket of shares) or index (or basket of indices) or other basis of reference, should recognise the complexities of utilising a Class in this manner. For example, the value of the relevant Class of Units may not exactly correlate with the value of the reference share (or basket of shares), index (or basket of indices) or other reference basis.

### ***Fund specific risks***

**Fund risk.** These are risks specific to the Fund. These risks include that the Fund could terminate, the fees and expenses of the Fund could change, Gyrostat Capital may be replaced as Trustee and the investment team may change. There is also a risk that investing in the Fund may lead to a different result than investing in the market personally because of income or capital gains accrued in the Fund and the consequences of investment by and withdrawal of other investors. If any of these risks are realised, the returns an investor receives from the Fund may be reduced.

**Key Person Risk.** This is the risk that key individuals are no longer able to fulfil their obligations in respect of the investment or administration of the Fund. The performance of the Fund may be dependent on the management skill of one or more individuals. If key personnel are no longer able to fulfil their obligations there is a risk that Gyrostat Capital may not be able to find suitably qualified replacement personnel and the performance of the Fund may suffer as a result.

**Legal and Regulatory Risk.** This is the risk that domestic or international laws or regulations are changed adversely in respect of the Fund or that regulatory supervision of transactions and reporting is performed by the Investment Manager and the Custodian at less than an appropriate standard. Legal, tax and regulatory changes could occur during the term of the Fund that may adversely affect the Units, the underlying assets or related derivatives. The regulatory environment is evolving, and changes in the regulation of any entities may adversely affect their value. Regulators and self-regulatory organisations and exchanges are authorised to take extraordinary actions in the event of market emergencies. The regulation of securities and derivatives transactions is an evolving area of law and is subject to modification by government and judicial action. The effect of any future regulatory change on the Fund, its underlying or related derivatives could be material, including clearing and margin requirements for derivatives and consequently may adversely affect the value of the Units. The terms and conditions of the Units are based on relevant laws in effect as at the date of this Information Memorandum. No assurance can be given as to the impact of any possible judicial decision or change to such laws, or the official application or interpretation of such laws or administrative practices after the date of this Information Memorandum. Gyrostat Capital cannot predict what the outcome of any of these risks occurring may be. However, an outcome could be that the performance of the Fund is negatively impacted.

**Taxation Risk.** Gyrostat Capital will not be giving legal or tax advices to the investors. An investor's effective yield on the Class of Units they hold may be diminished by the tax on that investor of its investment in the Units. Potential purchasers and sellers of the Units should be aware that they may be required to pay taxes or documentary charges or duties in accordance with the laws and practices of the jurisdiction where the Units are transferred or other jurisdictions. In some jurisdictions, no official statements of the tax authorities or court decisions may be available in relation to the tax treatment of financial instruments such as the Units. Prospective investors are advised not to rely upon the tax summary contained in this Information Memorandum but to ask for their own tax adviser's advice on their individual taxation with respect to the acquisition, holding, disposal and redemption of Units. Only such adviser is in a position to duly consider the specific situation of the prospective investor.

**Dependency upon Certain Counterparties.** In certain cases, the ability of Gyrostat Capital to meet its obligations may depend on the receipt by it of certain payments from an underlying fund or assets (if any) and/or on the receipt by it of payments under a relevant derivative contract, deposit or any other agreement, notwithstanding the performance of any relevant underlying fund or assets. Consequently, investors will be exposed to a payment delay or failure in respect of any underlying fund, derivative contract or assets and/or the ability of the counterparty to any such agreement to perform its obligations under such agreement and to the creditworthiness of such counterparty. Gyrostat Capital will depend upon each of the Investment Manager and the Custodian, to perform their respective obligations under the Investment Management Agreement and the Custody Agreement as applicable. If

any of such entities becomes unable to perform its obligations under the Investment Management Agreement and the Custody Agreement as applicable due to insolvency or otherwise, this may affect the Gyrostat Capital's ability to make payments to investors and investors may not receive all, or any part, of the amounts due to them in respect of the Units and/or such payments (if any) may be delayed.

**No Secondary Market and Illiquid Units.** There can be no assurance that a secondary market will develop in respect of the Units. Units may have no established trading market when issued, and one may never develop. If a market does develop, it may not be very liquid. Therefore, investors may not be able to sell their Units easily or at prices that will provide them with a yield comparable to similar investments that have a developed secondary market. The Units may have a limited or no secondary market.

**Exchange Rate Risks.** Gyrostat Capital will pay amounts (distributions and redemption proceeds) relating to Units in Australian Dollars. This presents certain risks relating to currency conversions if an investor's financial activities are denominated principally in a currency or currency unit (the **Investor's Currency**) other than Australian Dollars. These include the risk that exchange rates may significantly change (including changes due to devaluation of the Australian Dollar or revaluation of the Investor's Currency) and the risk that authorities with jurisdiction over the Investor's Currency may impose or modify exchange controls. Government and monetary authorities may impose (as some have done in the past) exchange controls that could adversely affect an applicable exchange rate. As a result, investors may receive less amounts than expected, or no amounts at all.

**Investment Ratings may not Reflect All Risks.** One or more independent rating agencies or asset consultants may assign investment ratings to the Classes of Units or a specific Class of Unit. The ratings may not reflect the potential impact of all risks related to structure, market, additional factors discussed above, and other factors that may affect the value of the relevant Class of Units. A rating is not a recommendation to buy, sell or hold Classes of Units (or the relevant Class of Units) and may be revised or withdrawn by the relevant rating agency or asset consultant at any time. During its holding of a Unit, an investor should take such steps as it considers necessary to evaluate the on-going risks and merits of a continued investment in such Units. Such steps should not rely solely on ratings. During the global financial crisis, rating agencies have been the subject of criticism from a number of global governmental bodies that they did not downgrade entities on a sufficiently quick basis. Prospective investors who place too much reliance on ratings, or who do not understand what the rating addresses, may be subject to losses as a result.

**Trading in the underlying assets may be suspended, interrupted or terminated.** If the underlying assets are listed on one (or more) markets (which may be regulated or unregulated), the listing of such underlying assets may – depending on the rules applicable to such stock exchange – be suspended or interrupted by the respective stock exchange or a competent regulatory authority upon the occurrence of a number of reasons, including violation of price limits, breach of statutory provisions, occurrence of operational problems of the stock exchange or generally if deemed required in order to secure a functioning market or to safeguard the interests of investors. Furthermore, trading in the underlying assets may be terminated, either upon decision of the stock exchange, a regulatory authority or upon application by Gyrostat Capital and existing orders for the sale or purchase of such underlying assets will usually be cancelled. Investors should note that Gyrostat Capital has no influence on trading suspension or interruptions (other than where trading in the underlying assets is terminated upon Gyrostat Capital's decision) and that investors in any event must bear the risks connected therewith. Furthermore, a trading suspension, interruption or termination of the underlying assets may well result in an artificial or wrong valuation of the Units. Finally, even if trading in underlying assets is suspended, interrupted or terminated, investors should note that such measures may neither be sufficient nor adequate nor in time to prevent price disruptions or to safeguard the investors' interests. All these risks would, if they materialise, have a material adverse effect on the investors.

**Financing risk.** If a prospective investor in the Fund decides to finance the purchase of Units through funds borrowed from a third party, it should make sure in advance that it can still continue to service the interest and principal payments on the loan in the event of a loss. It should not rely on gains or profits from the investment in the Fund which would enable it to repay interest and principal of the loans when due and payable.

**Reinvestment risk.** Units may be redeemed in specified circumstances set out in the Trust Deed (including, without limitation, at a price less than their issue price). An investor generally may not be able to reinvest Unit redemption proceeds at an effective rate of return as high as the return on the Units being redeemed and may only be able to do so at a significantly lower rate of return. Prospective investors should consider reinvestment risk in light of other investments available at that time.

**Derivative Investment Risk.** Derivatives can be used to reduce risk or gain exposure to other types of investments. The Fund's use of options positions may include but is not limited to, acquiring or disposing of ASX (or other relevant exchanges) listed options

for purposes of benefiting from large market falls on the ASX200 (or other relevant exchanges). The Fund can use derivatives, including exchange traded options, to gain exposure to underlying assets. The Fund can suffer losses in excess of the amounts committed to relevant derivatives. The Fund will also be exposed to the risk that a derivative may not necessarily reflect the performance of the underlying asset to which it is exposed. Additional risks associated with investing in derivatives may include: potential illiquidity of the derivative; the Fund not being able to meet payment obligations as they arise; and counterparty risk (where the counterparty to the derivative contract cannot meet its obligations under the contract). Gains or losses can result from investments in derivatives. Investment in derivatives may increase the losses that would otherwise have been experienced if the derivatives had not been used.

**Liquidity risk.** Liquidity risk is the risk that the Fund's assets will not be able to be sold readily or for their fair value. If a disproportionate amount of the Fund's assets consists of illiquid assets, the Fund may not be able to realise sufficient assets to satisfy withdrawal requests from investors and investors may not be able to receive some or all of the capital they have invested in the Fund.

**Cross Liability.** The Fund is able to create different classes of Units with segregated assets and liabilities from time to time. The assets of each Class are held on a segregated basis. However, each Class is not a separate legal entity or separate trust. Significant creditors of a Class will be requested to limit their recourse to the specific assets and liabilities of the relevant Class. However, there is no assurance that such creditors will agree to limit their recourse to the relevant Class or, even if recourse is contractually limited to a particular Class, that such limitation on recourse will be effective in the insolvency of the relevant creditor or the Fund. Accordingly, there is a risk that a creditor of a Class (or the Fund generally) will have access to all of the assets of the Fund, in satisfaction of their claims.

**Cyber risk:** There is a risk of fraud, data loss, business disruption or damage to the information of the Fund or to an investor's personal information because of a threat or failure to protect the information or personal data stored within Gyrostat Capital's IT systems and networks or our service providers.

### ***Underlying investment risks***

**Investment risk.** The underlying investments of the Fund may fall in value for many reasons, such as changes in an investee entity's internal operations or management, or in the business environment in which the investee entity operates. If underlying investments fall in value, the value of an investment in the Fund will also fall in value.

**Market risk.** Economic, technological, political or legal conditions and market sentiment can (and do) change. These changes can lead to volatility in the value of investments and the overall level of liquidity in the market. This can affect the value of the Fund's investments and Gyrostat Capital's ability to realise the Fund's investments.

**Interest rate risk.** Changes in interest rates can have a positive or negative impact directly or indirectly on the Fund's investment values or returns. For example, as a result of interest rate changes, the cost of the borrowings of the investee entities in which the Fund invests can decrease or increase or the income return on a fixed interest security can become more or less favourable.

**Currency risk.** For Classes A, B & C the Fund predominantly invests in Australian stock and ASX options market. As set out in Class A, B & C investment strategy (see the section 'The Fund'), a specified percentage of the relevant Class assets may be invested in international assets (including the international options market). If the relevant Class is invested in international markets the fluctuation of exchange rates may in turn reduce the value of the relevant Class. For non-resident Australian investors the value of overseas currencies changes relative to the Australian dollar, will result in a change in the value of the investments of the relevant Class in their native currency. For Classes D & E the Fund invests in Hong Kong and US, respectively, denominated assets and fluctuation of exchange rates may reduce the value of the relevant Class when converted to Australian dollars.

**Derivative risk.** The use of derivatives by the underlying companies in which the Fund is invested may cause those securities to lose money which they would not have otherwise lost had they not used derivatives. If this occurs the value of an investment in the Fund may be reduced.

**Information risk.** Information risk is the risk of local investors not being fully informed of pertinent, price sensitive information about offshore investments or markets. Information risk can relate to political, town planning, business or even cultural issues. Information risk is particularly relevant for companies with non-Australian assets. If any of the underlying investments in which the Fund invests do not have all of the necessary local information, the returns that an investor receives from the Fund and the value of their investment in the Fund may be reduced.

**Regulatory risk.** This is the risk that, in respect of the Fund's underlying investments, domestic or international laws or regulations are changed adversely.

**Concentration Risk.** There may be more volatility in the Fund as compared to a broader market index due to the Fund investing in a smaller number of securities than the broader market index.

**Economic Risk.** Future earnings of the Fund and the value of investments held may be impacted by external market factors including the economic climate, global investment markets, domestic equity markets, currency movements, changes in government policy and other factors that are beyond the control of the Fund.

**Leverage:** As set out in each Class' investment strategy (see the section 'The Fund'), the Trustee may borrow up to a specified percentage of a Class' assets (measured at the time of debt incurrence) on a secured or unsecured basis. Depending upon the performance of the Fund and market conditions (including borrowing costs and borrowing terms), such borrowings may magnify losses in the Class or reduce a Class' profits. Further, in the event that the Trustee was unable to repay such borrowings, investors may suffer a loss equal to the amount recoverable by the relevant lender in respect of such borrowings. Borrowing repayments rank ahead of payments to investors.

## HOW THE FUND WORKS

### *Structure of the Fund*

The Fund is an unregistered managed investment scheme structured as a unit trust. Investments in the Fund are only open to wholesale clients as defined under the Corporations Act unless determined otherwise by Gyrostat Capital (see “Eligible Investors” in the “How to Apply” section for more information on whether you will qualify as a wholesale client).

When you invest in the Fund, you will be issued units in the Fund (**Units**). The Fund currently offers five Classes. You need to specify in your Application Form which Class you are applying for. Each Class gives you an entitlement to a share of the capital and income of that Class only. However, you are not entitled to any specific assets of the Fund. Generally, the value of your Units may rise or fall depending on the market value of the assets held for the Class you have invested in. Gyrostat Capital does not guarantee the return of any capital you invested in the Fund or any specific level of return on your investments.

Gyrostat Capital will determine the Net Asset Value of each Class on each Business Day in order to calculate the Unit issue price, Unit withdrawal price and Performance Fee for that month for each Class.

### *Applications*

You can apply for Units by sending us an application form and your application money.

Units in the Fund will be issued on each Business Day. Applications received after 3pm Australian Eastern Time are processed the following Business Day.

The issue price for a Class will be an amount equal to the Net Asset Value per Unit in that Class (calculated as at the Issue Date), plus the Buy Spread (refer Fees and Costs section below).

In addition to making an initial investment, you can also make additional investments in the Fund, or reinvest your distributions into the Fund.

### *Withdrawals*

Gyrostat Capital may accept your withdrawal request at its discretion. Under the Trust Deed, Gyrostat Capital is not obliged to offer Unit Holders the opportunity to make, or to give effect to, a withdrawal request. If we accept your withdrawal request, withdrawal proceeds will be paid to you within 30 Business Days of the Withdrawal Date. A withdrawal may be effected by the redemption/cancellation of your Units (in whole or in part) or by the purchase of such Units by Gyrostat Capital (or a third party nominated by Gyrostat Capital) (in whole or in part).

Under the Trust Deed, Gyrostat Capital may honour withdrawal requests at its absolute discretion. Gyrostat Capital has not, to date, exercised its discretion to; (i) not honour a withdrawal request; or (ii) extend the period allowed to satisfy a withdrawal request. Gyrostat Capital may, at its discretion, extend the period allowed for satisfying a withdrawal request until a later Withdrawal Date if, in its opinion, it has taken all reasonable steps to realise sufficient Assets to satisfy a withdrawal request and is unable to do so due to one or more circumstances outside its control (such as restricted or suspended trading in the market for an Asset), it does not consider it to be in the best interests of the Unit Holders as a whole or Unit Holders in a Class to realise sufficient Assets to satisfy the withdrawal request; or if it is, for any reason, impractical to calculate the Net Asset Value of the relevant Class, including because of the closure of an exchange or trading or withdrawal restrictions in respect of an Asset. This is permitted under the Trust Deed.

You may request to withdraw your Units in the Fund by sending a withdrawal request to us in writing. If we receive your withdrawal request before 3pm Australian Eastern Time on a Business Day, you will receive the withdrawal price calculated as at the close of business on that Business Day or, if we receive your withdrawal request after that time, you will receive the withdrawal price effective for the next Business Day (**Withdrawal Date**).

The withdrawal price is an amount equal to the Net Asset Value of the Class (taking into account any accrued Management and Performance Fees) per Unit being withdrawn (calculated as at the Withdrawal Date), less the Sell Spread (refer Fees and Costs section below).

### *Unit pricing*

The Unit price for the Fund is calculated as at the close of business on every Business Day.

## ***Distributions***

The current distribution policy of the Fund in respect of each Class of Units is set out in the section 'The Fund'. The Fund may revise its distribution policy at any time.

The Trustee intends pay distributions to investors on a calendar quarterly basis. You will receive your distribution payment within 60 days following the end of the relevant calendar quarter.

The amount of distribution paid to each investor is calculated by dividing the total amount to be distributed for a Class, which is determined by us, by the total number of Units on issue in that Class at the distribution calculation date and multiplying the result by the number of Units in that Class held by the relevant investor on that distribution calculation date. The current distribution calculation dates are 30 March, 30 June, 30 September and 31 December. Gyrostat Capital reserves the right to suspend distributions of any (or all) Classes at any time.

You may elect to have your distributions from the Fund paid by electronic funds transfer into your nominated account, reinvested in additional Units at the issue price effective for the next Issue Date or a combination of both. If you do not make a choice, or if a direct credit rejection occurs, then your distributions are automatically reinvested in the Fund.

## ***Transfers***

Investors may transfer Units held in the Fund. The purchaser of the Units must otherwise be eligible to invest in the Fund. Gyrostat Capital may decline to register a transfer of Units at its sole discretion.

## ***Additional Investments***

Additional investments may be made by completing an Application Form together with a transfer of the additional investment funds into our account. Currently, no minimum investment amount applies to additional investments. Additional investments are made on the terms and conditions set out in the IM current at the time the additional investment is made. The Trustee reserves the right to impose conditions relating to additional investments upon 30 days' notice to investors.

No minimum additional investment applies to the reinvestment of distributions.

## ***Class Switches***

Investors may switch all or part of their holding of a particular Class of Units into one or more other Classes of Units by sending to us a Class Switch Form. Currently, no minimum investment amount applies to Class Switches, but a switch transaction must be at least \$5,000. Class Switches made on the terms and conditions set out in the IM current at the time the Class Switch is made. The Trustee reserves the right to impose conditions relating to Class Switches upon 30 days' notice to investors. A Buy/Sell Spread is payable in respect of a Class Switch.

## ***Confirmation***

Confirmation of the number of Units issued to you following your initial investment and additional investment will be forwarded to you as soon as is reasonably practicable, which will usually be within 10 Business Days of Units being issued.

## ***Electronic instructions***

If you instruct Gyrostat Capital by electronic means, such as facsimile, email or internet, you release us from and indemnify us against all losses and liabilities arising from any payment or action we make based on any instruction (even if not genuine) that we receive by an electronic communication which appears to indicate to us that the communication has been provided by you (e.g. a signature which is apparently yours or that of an authorised signatory for the investment or an email address which is apparently yours). You also agree that neither you nor anyone claiming through you has any claim against Gyrostat Capital or the Fund in relation to any such payment or action. There is a risk that a fraudulent withdrawal request can be made by someone who has access to your investor details and a copy of your signature or your email address. Please take care.

### ***Information about your investments***

We will provide you with the following information about your investments in the Fund.

<b>Transaction statements</b>	A confirmation statement for each application for Units or withdrawal request made by you.
<b>Annual taxation statement</b>	An annual statement, which confirms distributed income and its components for the last financial year.
<b>Monthly report</b>	Monthly performance report to investors.
<b>Annual report</b>	Yearly report to investors.

## FEES AND COSTS

### *Buy/Sell Spread*

Investments in, and withdrawals from, managed funds such as this Fund are commonly subject to a buy/sell spread, which reflects the transaction costs incurred by us as the Trustee of the Fund in buying and selling assets when Units in the Fund are issued or redeemed. These costs are additional costs to you.

The application of the buy/sell spread aims to ensure that each investor bears the same proportion of transaction costs associated with their entry to, or exit from, the Fund. The buy/ sell spread is charged because entering or exiting the Fund may necessitate fund administration expenses and may involve the purchase or disposal of assets by the Fund.

The amount of the buy/sell spread represents an estimate by us, as the trustee, of the transaction costs that are likely to be incurred in fund administration, or when buying or selling assets, such as brokerage, government charges, taxes (including stamp duty), commissions, underlying investments buy/sell spread and like costs. Such costs are incurred in the day-to-day management of the Fund and are paid directly from the Fund.

The Fund plans on charging a buy-sell spread of +/-0.15% of NAV for both the Issue and Withdrawal of Classes of Units. However, this fee is an estimate only and is subject to change. The buy-sell spread is also payable on a Class Switch.

### *Management Fees and Expenses*

Gyrostat Capital will be responsible for all administrative aspects of the Fund's affairs, including, reporting to Investors, fulfilment of all applicable statutory requirements, and the preparation of accounts.

Gyrostat Capital is entitled to receive a Management Fee of 1.3% (plus GST) per annum for the Gyrostat Leveraged Absolute Return Income Equity Class, 1% (plus GST) per annum for all other Classes, of the Net Asset Value of each Class each month calculated based on the Net Asset Value of the relevant Class at the end of each month. The Management Fee accrues daily is payable monthly in arrears.

Gyrostat Capital Management Advisers Pty Ltd has been appointed as Investment Manager In its role as Investment Manager it will be responsible for investigation of opportunities, due diligence, investment of funds, exit from investments and other related activities. Gyrostat Capital will pass on all of the Management Fee and Performance Fees that it is entitled to receive to Gyrostat Capital Management Advisers Pty Ltd.

All expenses properly incurred by Gyrostat Capital in connection with the Fund (including the establishment of the Fund) or in performing obligations under the Trust Deed, are payable or can be reimbursed out of the Fund. These expenses include but are not limited to professional services for administration, custodial, accounting, audit, taxation and legal advice, as well as other costs including transactional and government charges, and general running and office expenses. Such expenses will generally be allocated to each Class in proportion to the Net Asset Value of the relevant Class to the Net Asset Value of all Classes, (unless the expense relates to a certain Class or Classes in which case it will be allocated to the relevant Class/es on a proportionate basis).

The amount of expenses payable from the Fund's assets is unlimited but will be charged as a capped expense recovery fee 0.5% of the Net Asset Value of the relevant Class per annum, for all usual and ongoing expenses of the Fund.

Gyrostat Capital reserves the right to recover expenses that it deems to be unusual or non-recurrent and can be charged to the Fund in addition to the capped expense recovery fee. These expenses are not generally incurred during the day-to-day operation of the Fund and are not necessarily incurred in any given year. They are due to abnormal events, for example, the Fund formation costs, the cost of running Unit Holder meetings, or legal costs incurred for changes in the Trust Deed. Such unusual or non-recurrent expenses will generally be allocated to each Class in proportion to the Net Asset Value of the relevant Class to the Net Asset Value of all Classes (unless the expense relates to a certain Class or Classes in which case it will be allocated to the relevant Class/es on a proportionate basis).

### *Performance Fees*

The Investment Manager will be entitled to receive the Performance Fee from the Fund in respect of each Class, equal to 15% (including GST, net of reduced input tax credits) of the increase in Net Asset Value per Unit of the relevant Class during the 3 months to 31 March, 30 June, 30 September and 31 December each year, subject to increase in the Net Asset Value per Unit of the relevant Class being greater than the increase at the Hurdle Rate of the relevant Class (described below) and subject to High Watermark of the relevant Class (also described below). The Performance Fee is calculated and accrues daily in the manner detailed below and is payable within 30 days of the end of each calendar quarter.

This fee is calculated by the Fund Administrator and invoiced directly to the Fund on a calendar quarterly basis.



Only once the Units of the relevant Class have increased in value and made up the under-performance from previous quarters (i.e. exceeded the High Watermark of the relevant Class of Unit), and performance is in excess of the Hurdle Rate of the relevant Class, will a Performance Fee in respect of the relevant Sub-Fund be paid at the end of the calendar quarter.

When a Performance Fee in respect of the relevant Class is paid it is calculated by multiplying the increase in the Net Asset Value per Unit of the relevant Class in excess of the High Watermark of the relevant Class for each subscription during the calendar quarter, as at the day on which the Performance Fee is calculated by 15%, subject to this increase being in excess of the Hurdle Rate of the relevant Class.

Performance Fees are calculated on the Net Asset Value per Unit of the relevant Class before accrued Performance Fees and before any distributions. The total Performance Fee is calculated and accrues each month based on the performance of individual Units of the relevant Class of Units (i.e. the Performance Fee may be different for different investors as the Hurdle Rate will be applied to the issue price of each issue of the relevant Class of Units which are likely to be issued at different prices from month to month). The accrued Performance Fees are aggregated at the end of each calendar quarter. The accrued Performance Fee at the end of each calendar quarter is then divided by the number of Units of the relevant Class on the register at the end of the calendar quarter so that all investors of the relevant Class bear the Performance Fee notwithstanding that it is calculated by reference to the performance of each Unit of the relevant Class.

If a Unit Holder of the relevant Class redeems their Units before the Performance Fee is paid, the withdrawal price of the relevant Class will take into account any accrued Performance Fee.

### ***Hurdle Rate***

The Hurdle Rate for each Class of Units for each calendar quarter is set as at 1 January, 1 April, 1 July and 1 October each year.

#### **Gyrostat Absolute Return Income Equity Class or Class A Units**

The Hurdle Rate for Gyrostat Absolute Return Income Equity Class Units is based on BBSW90 + 300 bp (3.0%) p.a. as at those dates. Gyrostat Absolute Return Income Equity Class Units in the Fund will be available for subscription on a daily basis. The same Hurdle Rate will apply for each subscription of Gyrostat Absolute Return Income Equity Class Units until the end of a calendar quarter. For example, if the BBSW90 is 3.2% on 1 January, the Hurdle Rate for Gyrostat Absolute Return Income Equity Class Units for that whole calendar quarter will be calculated as follows:

Hurdle Rate for Gyrostat Absolute Return Income Equity Class Units =  $[3.2\% + 3\%] \times [90/365]$  (i.e. the number of days in the calendar quarter).

For an investor that subscribes for Gyrostat Absolute Return Income Equity Class Units to be issued during January, February and March the Hurdle Rate will be the rate set on 1 January and will apply for each subscription of Gyrostat Absolute Return Income Equity Class Units until the end of a calendar quarter.

For existing Gyrostat Absolute Return Income Equity Class investors in the Fund as at the date of this IM, the Hurdle Rate will apply to the Net Asset Value per Gyrostat Absolute Return Income Equity Class Unit as at the commencement of the quarter.

#### **Gyrostat Leveraged Absolute Return Income Equity Class or Class B Units**

The Hurdle Rate for Gyrostat Leveraged Absolute Return Income Equity Class Units is based on BBSW90 + 300 bp (3.0%) p.a. as at those dates. Gyrostat Leveraged Absolute Return Income Equity Class Units in the Fund will be available for subscriptions on a daily basis. The same Hurdle Rate will apply for each subscription of Gyrostat Leveraged Absolute Return Income Equity Class Units until the end of a calendar quarter. For example, if the BBSW90 is 3.2% on 1 January, the Hurdle Rate for Gyrostat Leveraged Absolute Return Income Equity Class Units for that whole calendar quarter will be calculated as follows:

Hurdle Rate for Gyrostat Leveraged Absolute Return Income Equity Class Units =  $[3.2\% + 3\%] \times [90/365]$  (i.e. the number of days in the calendar quarter).

For an investor that subscribes for Gyrostat Leveraged Absolute Return Income Equity Class Units to be issued during January, February and March the Hurdle Rate will be the rate set on 1 January and will apply for each subscription of Gyrostat Leveraged Absolute Return Income Equity Class Units until the end of a calendar quarter.

For existing Gyrostat Leveraged Absolute Return Income Equity Class investors in the Fund as at the date of this IM, the Hurdle Rate will apply to the Net Asset Value per Gyrostat Leveraged Absolute Return Income Equity Class Unit as at the commencement of the quarter.

#### **Gyrostat Risk Managed Australian Equity or Class C Units**

The Hurdle Rate for Gyrostat Risk Managed Australian Equity Units is based on the ASX200 accumulation index as at those dates. Gyrostat Risk Managed Australian Equity Class Units in the Fund will be available for subscriptions on a daily basis. The same Hurdle Rate will apply for each subscription of Gyrostat Risk Managed Australian Equity Class Units until the end of a calendar quarter. For example, for an investor that subscribes for Gyrostat Risk Managed Australian Equity Class Units to be

issued during January, February and March the Hurdle Rate will be the rate set on 1 January and will apply for each subscription of Gyrostat Risk Managed Australian Equity Class Units until the end of a calendar quarter.

For existing Gyrostat Risk Managed Australian Equity Class investors in the Fund as at the date of this IM, the Hurdle Rate will apply to the Net Asset Value per Gyrostat Risk Managed Australian Equity Class Unit as at the commencement of the quarter.

#### **Gyrostat Risk Managed Hong Kong Equity or Class D Units**

The Hurdle Rate for Gyrostat Risk Managed Hong Kong Equity Units is based on the HSI Net Total Return Index as at those dates. Gyrostat Risk Managed Hong Kong Equity Class Units in the Fund will be available for subscriptions on a daily basis. The same Hurdle Rate will apply for each subscription of Gyrostat Risk Managed Hong Kong Equity Class Units until the end of a calendar quarter. For example, for an investor that subscribes for Gyrostat Risk Managed Hong Kong Equity Class Units to be issued during January, February and March the Hurdle Rate will be the rate set on 1 January and will apply for each subscription of Gyrostat Risk Managed Hong Kong Equity Class Units until the end of a calendar quarter.

For existing Gyrostat Risk Managed Hong Kong Equity Class investors in the Fund as at the date of this IM, the Hurdle Rate will apply to the Net Asset Value per Gyrostat Risk Managed Hong Kong Equity Class Unit as at the commencement of the quarter.

#### **Gyrostat Risk Managed Global Equity or Class E Units**

The Hurdle Rate for Gyrostat Risk Managed Global Equity Units is based on the MSCI All Country World Index as at those dates. Gyrostat Risk Managed Global Equity Class Units in the Fund will be available for subscriptions on a daily basis. The same Hurdle Rate will apply for each subscription of Gyrostat Risk Managed Global Equity Class Units until the end of a calendar quarter. For example, for an investor that subscribes for Gyrostat Risk Managed Global Equity Class Units to be issued during January, February and March the Hurdle Rate will be the rate set on 1 January and will apply for each subscription of Gyrostat Risk Managed Global Equity Class Units until the end of a calendar quarter.

For existing Gyrostat Risk Managed Global Equity Class investors in the Fund as at the date of this IM, the Hurdle Rate will apply to the Net Asset Value per Gyrostat Risk Managed Australian Equity Class Unit as at the commencement of the quarter.

### ***High Watermark***

For each issue of Units of a Class, the Hurdle Rate for that Class will be applied to the issue price of those Units and will be cumulatively applied to that issue price to determine the High Watermark for that Class.

Using the example above for Gyrostat Absolute Return Income Equity Class Units if the BBSW90 is 3.2% on 1 January the Hurdle Rate for Gyrostat Absolute Return Income Equity Class Units for that whole calendar quarter will be calculated as follows:

Hurdle Rate for Gyrostat Absolute Return Income Equity Class Units =  $[3.2\% + 3\%] \times [90/365]$  (i.e. the number of days in the calendar quarter) .

Therefore, the Hurdle Rate for Gyrostat Absolute Return Income Equity Class Units = 1.53%.

If Gyrostat Absolute Return Income Equity Class Units are issued at \$1.00 at the start of that calendar quarter, the High Watermark for those Class A Units would be \$1.0153 (i.e.  $\$1.00 \times 1.53\% + \$1.00$ ).

The Investment Manager determines whether the increase in the Net Asset Value per Unit of the relevant Class is in excess of the Hurdle Rate for that relevant Class of Unit applied to the Net Asset Value per Unit of that Class at the end of each calendar quarter.

For those investors whose increase in the Net Asset Value per Unit of a Class is in excess of the Hurdle Rate for that Class and their High Watermark, they are consolidated into the one group of Units for a Class and the next quarterly High Watermark of the Class of Units will be the same for all of those investors.

In the event that the High Watermark of the relevant Class has not been met for a calendar quarter, a separate High Watermark of the relevant Class will be established for the first issue of Units of the Class in the next calendar quarter. This is calculated by applying the Hurdle Rate for the relevant Class of Units to the Net Asset Value of the relevant Class as at the first day of the next quarter. In this case the Hurdle Rate for the relevant Class applied to issue price becomes the High Watermark of the relevant Class. Only upon the Net Asset Value of the Class of Units increasing in excess of the High Watermark of the Class will a Performance Fee be paid. The High Watermark of the relevant Class will be adjusted for any distributions to investors of the Class.

At the end of each calendar quarter, the Class Performance Fee is calculated based upon the excess of the High Watermark of the Class multiplied by the number of Units of the relevant Class that are subject to a Performance Fee.

This means that, notwithstanding that the Performance Fee is calculated based on the performance of each Unit of a Class, the amount of the Performance Fee is deducted from the assets of the Class as a whole .i.e. all investors of the relevant Class bear the Performance Fee of the relevant Class.

### ***Fee increases and alterations***

Fees and charges are current at the date of this IM. Gyrostat Capital may increase fees up to the maximum amounts permitted under the Trust Deed. Under the Trust Deed, Gyrostat Capital may also change the frequency in which Management Fees, expense recoveries and Performance Fees are calculated and paid. Gyrostat Capital does not currently intend to increase the fees and charges set out in this IM but may do so in the future by providing 30 days' notice.

### ***GST***

All fees stated in this information memorandum are exclusive of GST unless otherwise stated.

## **TAXATION**

The following is a discussion of taxation issues relevant to an investment in the Fund by investors who are Australian residents for tax purposes and who hold their investment in the Fund on capital account only. Investors who carry on a business of trading in Units or securities should obtain their own tax advice.

As the Australian taxation system is complex and individual Investors have different circumstances, potential Investors are urged to seek professional taxation advice before investing in the Fund. Investors who are non-residents of Australia are urged to seek their own tax advice prior to investing in the Fund.

The tax discussion in this IM is based on our interpretation of the current Australian tax laws at the date of publication of this document, including applicable case law and published guidance by the Australian Taxation Office, which may be subject to change. Reliance should not be placed on the brief and general information provided below.

### **Fund structure**

On the basis that the Fund meets the requirements for being an eligible Managed Investment Trust ('MIT') for tax purposes, the Trustee intends to make an irrevocable election under the MIT provisions to treat certain eligible assets of the Fund (primarily, equity investments) as being held on capital account.

The Fund may also qualify for and may irrevocably choose to apply the Attribution MIT ('AMIT') rules. If the Fund qualifies as an AMIT, the Trustee intends to elect to apply the AMIT rules to the Fund and its Classes. By making a Class election for AMIT purposes, each Class of the Fund is effectively treated as a separate fund for tax purposes. The content in this section assumes that the Trustee will make those elections.

Eligibility for MIT/AMIT status will depend on satisfying the widely held and closely held thresholds for the Fund. This will ultimately depend on the nature and holdings of the Fund's investors.

Regardless of whether the Fund qualifies as a MIT or AMIT, the Fund should not pay tax provided that the Fund distributes, allocates or attributes (as relevant) all of its net income in a financial year.

You will need to include in your income tax return your share of the Fund's taxable income for each financial year. This applies regardless of whether the distribution of all of that income is received in cash during that income year or a later year, and may include amounts that have been reinvested.

To assist you in completing your tax return, you will receive an annual tax statement from us. This statement will provide you with the components to be included in your tax return. The sum of these components may differ to the amount of cash distributions you receive.

Tax losses (if any) generated by any Class of the Fund cannot be passed onto investors. However, provided specific requirements are satisfied, that loss should be able to be carried forward and offset against income generated in a later income year by that Class.

### **Income**

The Fund intends to distribute all of its net income each financial year to investors.

The Fund is a flow-through for tax purposes, and Gyrostat Capital will not be liable to pay tax on behalf of the Fund or investors (Gyrostat Capital may be required to withhold on some distributions) where the Fund distributes all of its net income in a financial year. Your share of the taxable income of the Fund for each financial year (including reinvested income) forms part of your assessable income.

### **Dividends**

Where franked distributions are received in relation to investments in Australian equities, you may receive franking credits as part of your distribution (subject to relevant franking credit integrity measures, such as the 45-day holding period rule). These franking credits will not represent part of your cash receipts but will need to be included in your tax return as part of your taxable income. Depending on your individual circumstances, these may be available to offset your income tax liability or be paid as a refund.

### **Capital Gains Tax**

Where a Class of the Fund derives net capital gains to which you become entitled, investors will typically need to include these amounts in their assessable income. Investors will generally be required to double any discounted capital gains. A capital gains tax ('CGT') discount may then be available for some investors, as outlined below. **Disposal of Units**

When you fully or partially withdraw or redeem your investment in a Class of the Fund, you are treated as having disposed of your investment, and as a result, any net gain derived on disposal may be included in your taxable income under the CGT provisions. This may include where you move between Classes within the Fund.

An investor will make a capital gain in respect of the disposal of their investment to the extent that the capital proceeds attributable to the disposal exceed the investor's cost base. Alternatively, an investor will make a capital loss in respect of the disposal of its investment to the extent that the capital proceeds attributable to the disposal of the investment are less than the CGT reduced cost base in that investment.

In determining the cost base or reduced cost base of your investment in a Class of the Fund, you will need to take into account any returns of capital and certain tax components of distributions that will increase or decrease the cost base of your investment (which should be reported on your annual tax statements).

If the Fund is subject to the AMIT rules, where the amount of cash distribution is more than your share of the taxable income of that Class in an income year, your CGT cost base of the investment in that Class should decrease by the difference ('AMIT cost base net amount – excess') (or known as 'tax deferred' for a non-AMIT fund). These amounts may have the effect of increasing your capital gain or decreasing your capital loss.

Conversely, where the amount of cash distribution from the Class in which you have invested, assuming it is an AMIT, is less than your share of the taxable income of that Class in an income year, your CGT cost base of the investment in that Class should increase by the difference ('AMIT cost base net amount – shortfall'). This amount should have the effect of decreasing your capital gain or increasing your capital loss upon disposal of your investment.

Where the Fund is an AMIT, the annual tax statement you receive will state the amounts that the Trustee reasonably estimates to be the 'AMIT cost base net amount – excess' and the 'AMIT cost base net amount – shortfall'.

Any net capital loss resulting from the disposal of your investment in a Class of the Fund may be able to be used to reduce capital gains derived in that or future income years.

Investors that are individuals and trusts may be entitled to a CGT discount that reduces their capital gains by 50% where they have held their investment for more than 12 months. Investors that are complying superannuation funds may be entitled to a 33.33% reduction of their CGT liability. No such discount is available to corporate investors.

### **Foreign Income Tax Offsets**

Where a Class of the Fund derives foreign sourced income including dividends from foreign companies, Australian tax resident investors may be able to claim a Foreign Income Tax Offset ('FITO') against their Australian income tax liability in respect of their share of any foreign tax paid on that income. FITOs not utilised in the income year in which they are derived will be forfeited and cannot be carried forward to a later year.

### **Tax Deferred Components of Income**

A portion of the Fund's distributed income may include non-assessable amounts.

Certain non-assessable distributions to you will reduce the cost base of your Units in the Fund. This will be relevant when calculating the capital gain or loss (for capital gains tax purposes) on a subsequent redemption of Units on the withdrawal of the investment.

This information will be detailed in the tax report sent to investors annually.

### **GST**

Investors should not be liable to GST on the subscription, redemption or disposal of Units in the Fund.

Unless otherwise stated, fees and charges set out in this IM do not include amounts for GST. Where applicable, GST will be added to and form part of the fees and charges.

Where GST is included in the fees, charges, costs and expenses incurred by the Fund in respect of supplies it acquires, the Fund may be entitled to claim a reduced input tax credit for part of the GST on some of those supplies.

### **Tax File Number (TFN) and Australian Business Number (ABN)**

It is not compulsory for you to quote your TFN or ABN. If you are making an investment in the Fund in the course of a business or enterprise carried on by you, you may quote an ABN instead of a TFN. Failure by you to quote an ABN or TFN or claim an exemption may oblige us to withhold tax at the top marginal rate (including Medicare levy) on gross payments (including distributions of income) to you.

## OTHER INFORMATION

### *Trust Deed*

The Fund is governed by the Trust Deed. Copies of the Trust Deed are available from Gyrostat Capital free of charge. Some of the significant clauses of the Trust Deed are summarised below:

- **Trustee's Power**  
Under the Trust Deed, the Trustee has all powers in respect of the Trust that are possible to confer under the law on a trustee as though it were the absolute and beneficial owner of the assets of the Trust acting in its personal capacity.
- **Removal of Trustee**  
While the Fund is not a registered scheme, the Trustee may be removed as the trustee of the Fund by a resolution where the required majority is 90%. On the removal of the Trustee, the Trustee shall, in consideration of its removal as Trustee, be entitled to a fee payable from the Assets of 1% of the Net Asset Value of the Fund at the time of the Trustee's removal.
- **Distributions**  
The Trustee will distribute the taxable income of the Trust to ensure that it is not required to pay tax on any income that it receives. Investors are strongly advised to seek advice on the taxation consequences of investing in the Trust.
- **Limitation of liability**  
Subject to the Trust Deed and the law, a Unit Holder's liability in relation to a Unit Holder's investment in the Trust is limited to the amount (if any) which remains unpaid for their Units. The Trust Deed also limits the Trustee's need to compensate Unit Holders provided it acts in good faith and without gross negligence.
- **Fees**  
Under the Trust Deed, the Trustee has the right to charge a wide range of fees to Unit Holders in the Trust and recover these from the assets of the Trust. The Trustee has determined that, for the term of this IM that it will charge the fees set out in section 8. The Trustee may change these fees by providing Unit Holders with 30 days' notice.
- **Trust Deed amendments**  
Subject to the Corporations Act and any other approval that may be required by law, the Trustee may by deed replace or amend the Trust Deed or as otherwise permitted by the Corporations Act.
- **Related Party transactions**  
The Trust Deed does not prevent the Trustee from:
  - dealing with itself, as the trustee for a fund or in any other capacity, with an associate or any Unit Holder;
  - being interested in any contract or transaction with itself, as the trustee for a fund or in any other capacity, an associate or Unit Holder or retaining profits or benefits derived from any such contract or transaction; or
  - acting in the same or similar capacity in relation to any other managed investment scheme.It is intended that the Trustee, its related entities, their directors or employees may also invest in Units in the Trust.
- **Entitlement on death of Unit Holder**  
The Trustee may refuse to recognise the survivor or the legal personal representatives of the deceased, without providing any reason.
- **Other Conditions**

The Trust Deed includes the following points for consideration by a Unit Holder:

- The Trustee has the right to refuse to register a transfer.
- The Trustee shall convene a meeting of Unit Holders on receiving a request in writing to do so signed by a Unit Holder or Unit Holders holding not less than 20% of the issued Units
- The quorum for a Unit Holders meeting is 2 Unit Holders

## ***Investment Management Agreement***

The Investment Manager of the Fund has been appointed by the Trustee to be responsible for all the investment activities of the Fund. It is important that you are aware of some of the significant features of the Investment Management Agreement. Below is a summary of some of the significant clauses in the Investment Management Agreement.

- The Investment Manager is appointed for an initial period of 7 years. The Investment Management Agreement can be extended for a further 5 years at the option of the Trustee by providing written notice at least 6 months before the expiration of the initial term.
- The Trustee can terminate the Investment Management Agreement in a number of circumstances including if at any time the Investment Manager becomes insolvent, breaches a material breach of the agreement and fails to correct it within 30 days of notice of same.
- The Investment Manager is entitled to a management fee and the performance fee described in this IM.
- The Trustee appoints the Investment Manager as an authorised representative of the Trustee. This means that the Manager will be able to provide financial services under the Trustee's AFSL.
- The Investment Manager's duties include but are not limited to:
  - investing and managing the portfolio of assets for and on behalf of the Trustee;
  - producing monthly and annual reports that contain information relating to the investments including the name of all investments, the market value of the investments, the carrying value of the investments; and
  - doing all things necessary to ensure that the financial services provided by it and its representatives are provided with due care and skill and covenants that it will comply in all material respects with all relevant laws.
- The Investment Manager will have the powers of a natural person to deal with the portfolio and to do all things and execute all documents necessary for the purpose of managing the portfolio.
- The Trustee indemnifies the Investment Manager against any liabilities incurred by the Investment Manager and its directors, officers, employees, agents and delegates (which they may incur or which may be made against any of them as a result of or in connection with the appointment of or the exercise of the powers and duties by such a person.
- The Investment Manager indemnifies the Trustee against any losses or liabilities reasonably incurred by the Trustee arising out of, or in connection with, and any costs, charges and expenses incurred in connection with any gross negligence, fraud or wilful default of the Investment Manager.
- The Trustee will pay all taxes, costs, charges and expenses properly incurred in connection with the investment and management of the portfolio or the acquisition, disposal or maintenance of any investment of the portfolio.

## ***Anti-Money Laundering Regulations***

By applying for Units in the Fund you are taken to agree to the following terms:

- you warrant that you comply with all applicable anti-money laundering laws and regulations, including but not limited to the anti-money laundering laws and regulations of Australia (in force from time to time);
- you are not aware and have no reason to suspect that:
  - the money used to fund your investment in the Fund has been or will be derived from or related to any money laundering or other activities deemed illegal under applicable laws or regulations or otherwise prohibited under any international convention or agreement ("illegal activities");
  - the proceeds of your investment in the Fund will be used to finance illegal activities; and
  - you agree to promptly provide us with all information that we reasonably request in order to comply with all applicable laws and regulations relating to anti-money laundering.

We are required to obtain certain identification and verification information from you in respect of the Anti-Money Laundering and Counter-Terrorism Financing Act 2006, as amended from time to time. This information is requested in the Application Form.

## ***Privacy***

When you make an application to invest in the Fund, we will collect personal information from you in the Application Form. We may also collect additional personal information from you by other means in the future. If you have any questions about the personal information collected you should contact us.

You can request access to or change your personal information held by us by writing to us. We will assess your request in accordance with the National Privacy Principles.

The personal information that you supply to us will be used for the primary purpose of establishing your investment in the Fund and to verify your identity. Your personal information will also be used for the purposes of processing your application, administering your investment, complying with applicable laws and regulations for purposes related to our product and service development.

We may also use your personal information to forward to you, from time to time (including by email), details of other investment opportunities available to you from us. However, if you request, no information of that nature will be sent to you.

We will take reasonable steps to protect your personal information that we collect and ensure that the information is accurate and up-to-date. Investor information is held on secure servers or in storage locked in controlled environments. Our employees are required to maintain the confidentiality of any personal information held by us.

If you do not supply us with all the information we need, we may be unable to establish your investment in the Fund, process your application and administer your investment.

The types of organisations to which we may disclose the information provided by you include:

- with your consent, your financial adviser and dealer group;
- any third party service provider we may engage to provide custody, administration, technology, auditing, mailing, printing or other services;
- government authorities when, and to the extent, required by law; and
- our professional advisers (including legal and accounting firms, auditors, consultants and other advisers).

You can update or change your personal information by notifying our registry in writing at any time (including by email).

## ***Custodian***

The Fund has appointed One Managed Investment Funds Limited (OMIFL) under a Custody Agreement.

OMIFL has no supervisory role in relation to the operation of the Fund and has no liability or responsibility to a unit holder for any act done or omission made in accordance with the Custody Agreement.

The Custodian has not made any statement or purported to make any statement that is included in this IM or statement on which a statement made in this IM is based, except as set out in this paragraph.

The Custodian expressly disclaims all liability in respect of, makes no representation or any statement regarding, and takes no responsibility for, any part of this IM or any statements in or omissions in this IM other than the reference to its name. This applies to the maximum extent permitted by law and does not apply to any matter to the extent to which the consent is given.

The Custodian does not guarantee the return of any capital sums invested or any rate of return or the performance of any obligations.



## HOW TO APPLY

### *Eligible Investors*

An investment in the Fund is only open to wholesale clients for the purposes of the Corporations Act.

An investor is a wholesale client for the purposes of the Corporations Act, where any one of the following applies:

- the investor's investment is \$500,000 or more;
- the investor provides an accountant's certificate stating that the investor has net assets of at least \$2.5 million or has gross income of at least \$250,000 in each of the last two financial years;
- the investor is a "professional investor" (including those that hold an Australian Financial Services Licence (**AFSL**), are APRA regulated or have at least \$10 million worth of assets); or
- Gyrostat Capital is satisfied on reasonable grounds that the investor has suitable previous experience in financial products, subject to certain conditions.

Please refer to the Application Form for the type of written evidence that we will require to accept your investment as a wholesale client.
